ORDER

No.SO(BSP&CA)/HED/SP/4-2/2024:In exercise of the powers entrusted vide Government of the Punjab Services and General Administration Department (I&C Wing) Vide No. SO(Cab-I)2-4/2020(S.P) dated 14-09-2021, sanction is hereby accorded to grant of Qualification Allowance for MS / M.Phil. @ Rs.5000/- and for Ph.D. @ 10,000/- per month (Only one M.Phil. or Ph.D. allowance will be admissible) in respect of following officers w.e.f. the dates mentioned against their names in the light of Government of the Punjab, Finance Department, Notification No.FD.SR/9-21/2011, dated 01.04.2013 read with No. FD.SR-I/9-17/2013, dated 01.10.2013 and further clarified vide No. FD.SR-I/9-21/2016, dated 22-08-2019 and No. FD.SR-I/9-21/2016, dated 30.03.2020 subject to the following conditions: -

This Qualification Allowance / Special Allowance will not be admissible to those who have already drawn advance increments, on obtaining the degree of M.Phil. or Ph.D.

- 1. Either M.Phil. or Ph.D. Allowance will be admissible i.e. M.Phil. Allowance @ Rs. 5000/- per month would be discontinued on the receipt of Ph.D. Allowance @ Rs. 10,000/-.
- 2. The Qualification Allowance / Special Allowance for M.Phil. already drawn by the officer concerned @ Rs.1200/- per month w.e.f. 01-09-2007 in terms of Notification No. SO(SE-III)2-16/2007, dated 24-09-2007 or in terms of any other notification, would be discontinued.
